EFTO SKI UPDATE (2009-10 SEASON)

We will be offering the EFTO **"10 Pack"** ski pass prices at Kissing Bridge for the coming 2009-10 ski season. Kissing Bridge has told us that there will be price increases this year, so in addition to the ten packs we have worked out a deal on a new item called the **Canadian Partner Card**, which has a reduced cost and will interest some members of the group. **The ordering deadline is September 25, 2009.** Orders should be sent to John Telford c/o EFTO Office.

The adult **"10 pack"** package will be \$ 275 (Cdn). A Junior **"10 pack"** (13 years of age and under) will cost \$ 185, as will the Senior **"10 pack"** (65 years and older). All ten packs will include 4 lessons this season. We are also able to offer a mid-week pass **"Weekday Escape"** for \$ 170 (Cdn) and this too will include 4 ski lessons and a **TransPack** (20 transferable ski passes) for \$ 600 (no lessons are included). A season's pass is \$ 385 for those 18 and older (we have prices for those who are younger). We will have a flyer in the schools when school begins in the fall, or you can respond to this e-mail and I will forward the forms to you by e-mail.

The **Canadian Partner Card** will cost \$ 190 (Cdn) and includes 5 anytime 8 hour lift tickets and a lift ticket on each of the EFTO ski days (Jan.30th & Feb. 27th). As well 4 ski lessons are included between January 2nd and February 6th (for those over 9 years of age). The card will have a picture of the registrant on it and expires on April 25th.

A Ten Pack (This is a ski package that lets you ski 10 times in a season and is not transferable).	\$275 (Cdn) includes 4 lessons
A Canadian Partner Card (This is a ski package that lets you ski 7 times – 5 anytime days and the 2 EFTO ski days. It is not transferable).	\$ 190 (Cdn) includes 4 lessons
A Junior or Senior Ten Pack (This is a ski package that lets a Junior or Senior skier, ski 10 times in a season and is not transferable).	\$ 185 (Cdn) includes 4 lessons
A mid-week pass (Weekday Escape). This ski package can be used once per week, each week of the ski season, Monday to Friday.	\$170 (Cdn) includes 4 lessons
A TransPack . This ski package provides 20 transferable lift tickets that you can share with family and friends.	\$600 (Cdn)

In consideration of permission to use the Kissing Bridge Ski Area in Glenwood, NY, I expressly acknowledge:

- The Ski Area shall not be liable for any personal injury to me and/or damage to my personal property.
- I have read and understand the duties of passengers and skiers (sec. 18-104 of the NYS General Obligations Law), have retained a copy (pg.2) and agree to abide by it.
- Lift tickets, lessons and programs are not transferable. They may not be sold, traded or given away on penalty of forfeiture without refund.
- All lift tickets, lessons, rentals and skiing program sales are final. There are no refunds under any circumstances.
- I grant permission to Kissing Bridge to use any photograph, video, picture, recording or any other record of my use of its facilities for any legitimate purpose.
- At my request, I can receive a copy of article 18-NYS General Obligations Law from the Ticket Centre.

WARNING TO SKIERS

DOWNHILL SKIING LIKE MANY OTHER SPORTS, CONTAIN INHERENT RISKS INCLUDING, BUT NOT LIMITED TO THE RISK OF PERSONAL INJURY, INCLUDING CATASTROPHIC INJURY OR DEATH, OR PROPERTY DAMAGE, WHICH MAY BE CAUSED BY:

Variations in terrain or weather conditions or surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts bumps or other persons using the facilities, and or rocks, forest growth, debris, branches, trees, roots, stumps or other natural objects or man-made objects that are incidental to the provision or maintenance of a ski facility in New York State.

New York Law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, which are set forth above, so that you may make an informed decision whether to participate in skiing notwithstanding the risks. New York Law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing

IF YOU ARE NOT WILLING TO ASSUME ALL OF THESE RISKS AND ABIDE BY ALL OF THESE DUTIES, YOU MUST NOT PARTICIPATE IN SKIING AT THIS SKI AREA.

I have read and understand the above warning to skiers. By signing I signify that I am aware of, and accept the risks inherent to the sport of skiing and indicated in the Warning to Skiers. In addition, I understand that the programs sold by Kissing Bridge are not refundable.

*Kissing Bridge defines skiers/skiing as snowsports that may include the use of skis, snowboards and all other snow sliding devices.
